
Startup Boom in Switzerland continues after the Corona-led record year

St. Gallen/Zurich/Lausanne, 30. June 2021:

After the year 2020, which was marked by the COVID-19 pandemic, and went down in history as a record year in terms of the number of new companies founded, Switzerland is now heading for a new record this year. In the first half of 2021, 26'387 new companies were entered in the commercial register. This represents an increase of +20.9% compared to the same time period last year. The high increase compared to the first half of 2020 is partly due to the lockdown measures put in place at that time. The Swiss startup scene is showing optimistic signs and looks confident into the future.

In which areas are the startup scene booming?

Most new companies were established in the cantons of Zurich (4'638), Vaud (2'473), Bern (2'471) and Geneva with 2'173 new entries. These four cantons make up almost half of all new incorporations in Switzerland. But which cantons are the winners in percentage compared to the previous year? The canton of Schaffhausen recorded an increase of a remarkable +63.7% compared to the previous half year. Followed by Zug with +40.3%, Uri with +32.7% and Bern with an increase of +31.6%. Except for Appenzell Innerrhoden (-19.4%) and Obwalden (-9.2%), all cantons recorded a growth. The exact founding numbers and percentage changes are shown in the following chart.



Comparison of the last 10 years

Since modest decreases in 2012 and 2015, the Office of the Commercial Register has seen a consistent increase in new entries until 2020. In the first half of 2020, new entries dropped temporarily due to the COVID-19 measures. On average, 22'010 new companies were registered per half-year over the last 10 years. The current six months of 2021 show a significant growth of 20% over the 10-year average, with 26'387 new registrations.

Comparison of legal forms

In the first half of the current year, 10'024 new limited liability companies (LLC) were founded in Switzerland, representing an increase of +18.5%. Followed by the sole proprietorship with 8'743 new registrations (+21%), the public limited company (Ltd) with 5'212 new registrations (+25%) and the general partnership with 800 (+21.8%) registrations.



New companies by sectors

In terms of new companies by sectors, all sectors except for three are showing positive signs compared to the previous year. The top three growth sectors include Other Services (including video production, photography, facility management, gardening) with +69%, Agriculture & Forestry (+59.7%) and Retail Trade with +42.8%. The sectors with declines are Transport & Logistics (-3.5%) und High Tech (-1.6%).
